Community Perception

- When asked how important is it for Barber County to develop a community commercial kitchen, fifty-percent of survey respondents say it is important or very important.
- Survey respondents identified maintenance costs and renter/ user accountability as potential challenges to developing a community commercial kitchen in Barber County. Selecting a location that will meet the needs of all communities across the county was identified as another challenge.
- When asked to select from a list of the benefits of a community commercial kitchen, 57.1% selected both a place for gardeners to process produce for local resale and an opportunity for healthy food cooking classes.

Through the Pathways work, Barber County United will continue to build bridges with our countywide municipalities, organizations and community members as we strive to meet the most pressing needs of our county's population."

School districts USD 254 and USD 255 in Barber County have received *Pathways* grant funding to provide new opportunities and

Initiative Wide: In general, my community has sufficient options for healthy eating.



Key findings:

More than two-in-five respondents across the 24 *Pathways* communities said their community has sufficient options for healthy eating.

Results are based on data from an initative-wide survey of Blue Cross and Blue Shield of Kansas members for whom e-mail addresses were available in each of the 26 counties in which BCBSKS has funded coaltiions as part of the *Pathways to a Healthy Kansas Initiative*. N = 4,845. The survey response rate was 6.9 percent.





4,228 Population Impacted

Pathways to a Healthy Kansas combines evidence-based solutions and promising practices for improving healthy eating, active living and tobacco prevention to make a large impact in communities.
