### **Community Perception**

- Survey responses point to a need for educational spaces for demonstrations and presentations at the Downtown Lawrence Farmers Market.
- About half of customers at the Farmers Market were not aware of the Double Up Food Bucks or Senior Farmers Market Nutrition Program.
- About two-thirds of respondents feel that it is important to see greater representation of Asian American, Pacific Islander, Black, Indigenous, and People of Color farmers and business owners at the market.

#### **Healthy Eating**

This year, we're hosting a **Health in** All Policies Workshop to incorporate health in decision making at all levels, collaborating with Just Food, a food pantry, to enhance their reach, working with Lawrence Farmers Market to diversify market offerings, engaging the **Douglas County** Food Policy Council on promoting equitable

representation, and piloting a Healthy Food

Prescription Program with LMH Health.

#### **Active Living**



Baldwin City Junior High partnered with LiveWell Douglas County to integrate bike safety education into their physical education curricula. Thanks to

funding from the Pathways Initiative, the school was able to purchase a fleet of bicycles for students to use. As part of **Safe Routes to** School efforts. the Junior

High is also



providing safety education to schoolchildren.

#### **Commercial Tobacco Control**

The Tobacco Free Living Workgroup's efforts are in alignment with the goals of Pathways. The workgroup helped pass two comprehensive tobacco ordinances in the

City of Lawrence in the Fall of 2022. The Tobacco Retail Ordinance requires all retailers who sell tobacco products to be licensed to do so. The Clean Indoor Air Act was amended to include vaping.

## **Key findings:**

Three-in-five respondents across the 24 Pathways communities support commercial tobacco control policies in outdoor spaces.

Results are based on data from an initative-wide survey of Blue Cross and Blue Shield of Kansas members for whom e-mail addresses were available in each of the 26 counties in which BCBSKS has funded coalitions as part of the Pathways to a Healthy Kansas Initiative. N = 3,708. The survey response rate was 5.3 percent. For this question, 6.2 percent of respondents did not provide an answer (blank response)
