## **Community Perception**

- Residents near Polk Park in Fredonia were surveyed about needed improvements to a nearby park. 100% of survey respondents suggested at least 3 improvement to their neighborhood park.
- When asked what type of park improvements should be made, 60% of survey respondents requested new equipment that is suitable for younger children including playsets or equipment.
- 60% of survey respondents said that picnic tables for families should be a part of the park improvements. One respondent also requested trash cans.

### **Healthy Eating**

The **Downtown Grill** received a *Pathways* grant to support their goal of providing healthy food options to their customers. Grant funds were used to purchase a new refrigeration unit that increased their capacity to offer fresh salads and add a light plate selection to their menu.

#### **Active Living**



We completed construction for the **Riverwalk Park walking trail** in partnership with **City of Neodesha** and the **Active Transportation** 

Advisory Board. Uniquely positioned between the county hospital and the downtown area, this trail will promote community pride and physical activity. It also bridges accessibility and economic vitality.



#### **Commercial Tobacco Control**

We support **Resist** Chapters in **USD 484**, **USD 461**, and **USD 387**. **Wilson County** is the only Kansas county with an active Resist program in all their school districts. In

March 2023, Resist students went to the **State Capitol** to speak with their legislatures and advocate for commercial tobacco control.

## Initiative Wide: Level of support for commercial tobacco control policies in outdoor spaces



# **Key findings:**

Three-in-five respondents across the 24 *Pathways* communities support commercial tobacco control policies in outdoor spaces.

Results are based on data from an initative-wide survey of Blue Cross and Blue Shield of Kansas members for whom e-mail addresses were available in each of the 26 counties in which BCBSKS has funded coalitions as part of the Pathways to a Healthy Kansas Initiative. N = 3,708. The survey response rate was 5.3 percent. For this question, 6.2 percent of respondents did not provide an answer (blank response).
